

ARMY CENTRAL WELFARE FUND (CORPUS)

- 1 The Army Central Welfare Fund invites applications under the following Welfare Schemes :-
 - (a) Education grant (Class I to VIII – Rs 10,000/-, Class IX to XII – Rs 14,000/-, Graduation – Rs 20,000/-, Post Graduation – Rs 25,000/- and Professional Course – Rs 50,000/-(maximum) for the academic session 2016-17 for children of soldiers who have died in harness and have passed in all subjects. Application forms can be send directly to this office and there is no requirement of the signature of Zila Sainik Board.
 - (b) Wards of battle casualty should apply for full reimbursement of education grant to Ceremonial & Welfare Directorate (CW-3), AG's Branch, IHQ of MoD (Army), 206G, South Block, DHQ PO New Delhi-11 .
 - (c) Computer grant (one time grant of Rs 35,000/-) for wards of soldiers who have died in harness and pursuing graduation/professional courses.
 - (d) Mobility equipment for soldiers disabled in service (Only Amputee/Paraplegic/Tetraplegic/Quadriplegic or requires support for walking) and a grant of Rs 40,000/- for modification of bathroom (wheel chair bound only).
 - (e) Wheel chair bound soldiers who were given assistance by R&W Section earlier will be given a second wheel chair after completion of 7 years of the first issue.
 - (f) Marriage of daughters of Soldiers who have died in harness and war disabled soldiers (Rs 1,00,000/-).
 - (g) Remarriage of widows of Soldiers who have died in harness (Rs 1,00,000/-).
 - (h) Marriage of orphan Son (Rs 1,00,000/-).
 - (j) Education grant for widows of battle casualties (Fatal) and physical casualties (Fatal) for pursuing graduation (Rs 20,000/-), post graduation (Rs 25,000/-) and professional courses (Rs 50,000/- maximum).
- 2 Specimen application forms are available at all Veteran Cell of Area HQs/Sub Area HQs. Application forms can also be downloaded at www.indianarmyveterans.gov.in. Applications duly completed by NOK/soldier with necessary document for the above schemes should reach **Director (Corpus),R&W Section, Dte of Indian Army Veterans (DIAV), AG's Branch, Integrated HQ of MoD (Army), Adjacent to Central Org ECHS, 104 Cavalry Road, Delhi Cantt -110010. 3. Applications for marriage of daughters, orphan Son and re-marriage of Widows should reach this HQ minimum one month in advance. All applications should include bank details in the form of cancelled cheque/photostat copy of the front page of bank pass book. Incomplete applications will be rejected.
4. The applicant will enclose the following documents for education grant and forward to this office by 30 Nov 2017 :-
 - (a) Application form duly countersigned by the Principal of the school/college.
 - (b) Fees receipts in original.
 - (c) Copy of the mark sheet/result sheet passed, as on Mar 2017.
 - (d) Copy of the service booklet to include the details of wards.
 - (e) A cancelled cheque/ photostat copy of the front page of bank pass book.
 - (f) Mobile number must be mentioned and should be in use.
5. Original bill of computer alongwith above documents should be enclosed for the computer grant.
6. Grant will be transferred in individual bank account through NEFT before 31 Mar 2018.
