

Payment of Defence pension through banks in private sector

Please refer to your letter No B/27087/AG/PS-3(P) dated September 18, 2014 on the captioned subject seeking clarifications on the issue of opening of pension accounts by defence pensioners in private sector banks. We advise that as on date, banks in public sector along with three private sector banks viz. ICICI Bank Ltd, Axis Bank Ltd, and HDFC Bank Ltd are authorized to disburse defence pension.

2. As per the restrictions placed by Department of Financial Services vide letter F.No 7/10/2012-BO.II dated September 13, 2012, other private sector banks are not eligible to undertake government business, for the time being.
3. We further request you to route such issues through CGDA/PCDA in future.
